JIM KIRKLAND – MARION -DILLON HABITAT FOR HUMANITY

Jim Kirkland from Marion-Dillon County Habitat for Humanity introduced himself and stated that they were a 501C3 Special Needs Ministry and their goal was to build one decent affordable house at a time. They have two people approved for home ownership in Dillon County but need land immediately to build those homes and also need commercial property to establish a retail store for an office to work out of. He said that their cost to build was around \$91.00 per square foot and also added that the homes are three bedrooms and two baths and the cost is from \$115,000.00 to \$120,000.00 with a 0% interest mortgage which varies with a twenty, thirty or thirty-five year mortgage.

NATHAN SCALES - PUBLIC DEFENDERS OFFICE

Nathan Scales from the Public Defender's Office introduced himself and stated that he has worked in Dillon County since 2013 and with four different courts within the county. He asked that council add \$53,000.00 to his budget the same as the Solicitors Office gets. He went over the county crime statistics add concluded by saying that he hope that they would consider his request he would appreciate any help and assistance that he could get.

MAGISTRATE JUDGE MACKIE HAYES

Magistrate Judge Mackie Hayes stated that they need help with their finances because their budget has been cut numerous times and they desperately need another clerk. He went over the Magistrates Office budget from previous years. He asked that in the new budget, council give them what they're asking for and stop cutting their finds he also added that any consideration would be great.
